The scholarships we offer are partial, requiring a tuition contribution from each student's family. We partner with them, getting them involved in the educational experiences of their children. This is key to our success and sets *MinneapolisNEXT* apart from other organizations — as does our policy of having board-paid administrative costs, so that 100 percent of all donations directly benefit kids in need.
